CONSENT AGENDA

The General Manager presented the minutes of September 11th for board members approval. A motion was made by Lee Magee and seconded by Larry Fleming to approve the Consent Agenda as presented. Motion carried.

22-23 BUDGET AMENDMENT

During the February 13, 2023 meeting the Board voted to do a budget amendment to fund the Water Treatment Plant Upgrade Project. After the bond solicitation; this amendment is no longer needed and needs to be reversed. 6131.00 Water Treatment Plant Improvements -\$1,233,390.00. A motion was made by Lee Magee and seconded by Larry Fleming. Motion carried.

Resolution: The Board approved the 2022-2023 Budget Amendment as presented. (Res. #23-31)

23-24 BUDGET AMENDMENT

The Bond proceeds had to be placed into their own fund; therefore, the 9.9 million needs to be removed from the General Fund Budget.

Numerous other accounts are affected by payroll split that we have always done. The payroll split makes things more complicated for the Bookkeeper and CPA so we are eliminating the split and putting John as 100% distribution and Ray as 100% Park. No value change in the budget from these moves.

The Somervell County Water District has been asked by the Somervell Central Appraisal District to vote for board members for the Appraisal District Board of Directors. The board is made up of 5 voting members which are all currently up for renewal. The incumbents are Nemo Britton, Wade Busch, Brady Brown, Bill Moore and Neal Laws. All five incumbents are willing to continue serving on the Board. It is recommended SCWD split all its votes between the candidates.

A motion was made by Lee Magee and seconded by Kevin Morgan. Motion carried.

Resolution: Somervell County Water District cast its votes between Nemo Britton (68), Wade Bush (64), Brady Brown (64), Bill Moore (64) and Neal Laws (64) to serve on the Somervell Central Appraisal District Board of Directors.. (Res. #23-33)

SURFACE WATER STUDY

The Somervell County Water District Board of Directors spoke briefly last meeting about performing a surface water availably study to help the District quantify our current water availability and determine how many more new customers we could continue to supply. Originally thought there would be a charge for this, but there is no charge so no action is necessary.
