2021-2022 ANNUAL AUDIT

TREATMENT PLANT RECOMMENDATIONS AND ENGINEERING PROPOSAL

The Progressive Design Build option was recommended.

Recommendation II: It is recommended Somervell County Water District Board of Directors authorize the General Manager to negotiate with EHT for execution of an engineering and construction phase support services contract in an amount not to exceed \$1,233,390.00. The General Manager is also authorized to amend the 2022-2023 Budget for this expense.
