Your Water

Your water comes from Wheeler Branch Reservoir. Wheeler Branch Reservoir is a man made lake located approximately one mile north of Glen Rose. The lake is around 180 acres in surface area and can yield 2000 acre feet of water per vear, or about 650 million gallons. A Source Water Susceptibility Assessment for your drinking water source(s) is currently being updated by the Texas Commission on Environmental

Water and your Health

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune

system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Water Loss

In the water loss audit submitted to the Texas Water Development Board for the time period Jan-Dec 2015, our system lost an estimated 24,819,121 gallons of water. Lead in the Water?

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The District is responsible for providing high quality drinking water, but cannot control the vari-

ety of materials used in

plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Information on lead in drinking water,

testing methods, and steps you can take to minimize exposure is available from the Safe Drinking Water Hotline or at www.epa.gov/safewater/lead.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Contaminants in the Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally
 occurring or result from urban stormwater runoff, industrial or domestic
 wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Definitions

- MCL: Maximum contaminant level, the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- MCLG: Maximum contaminant level goal, the level of contaminant in drinking water below which there is no know or expected health risk. MCLGs allow for a margin of safety.

Disinfection Data

The District uses sodium hypochlorite as its disinfectant, our supplier is Hydro-Plus Inc. The disinfectant residual is measured in free chlorine in mg/L. The MRDL and MRDLG for chlorine is 4.0 mg/L as set by the EPA. Below are The Districts highest and lowest single results for the year 2015.

- pCi/L: Picocuries per liter (a measure of radioactivity)
- ppb: micrograms per liter or parts per billion - or one ounce in 7,350,000 gallons of water.
- ppm-mg/l: milligrams per liter or parts per million - or one ounce in 7,350 gallons of water.
- NTU: nephelometric turbidity units (a measure of turbidity)

- MRDL: The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- MRDLG: Maximum residual disinfectant level goal, the level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
